 - a. We will review donations that Brianne has gotten from sponsors and see if there are any we can allocate to volunteer prizes
 - 2. Judy motions that we input a tiered rewards system for volunteers where they can obtain rewards for collective hours volunteered. These hours have to be volunteered by the individual and cannot be transferred to another individual. The volunteer hours reset every season. Board members are not eligible for the reward system.
